The storage space is assigned by the city of Neresheim, there is no entitlement to a specific location. The ground for the storage and stand is meadow. Fire pits must burn in braziers. Waste bins are available.

6. Terms & Conditions

- (1) A historical appearance is a fundamental requirement for all participants. Technical equipment, electrical appliances and plastic utensils may/should not be used visibly. Self-sufficiency with authentic light sources is recommended. Electronic aids are not to be used for musical or other performances.
The market management has the power to order changes if necessary.
- (2) In the case of open fireplaces in the historic warehouse, there is an obligation to keep a fire extinguisher in place in accordance with the applicable legal approval regulations.
- (3) Each participating group is responsible for the disposal of garbage. A sufficient number of waste bins are available for visitors during the festival operation. Waste water must be disposed of in the toilets, the emptying of waste water into meadows or vegetation is prohibited.
- (4) Participating historical groups commit to participating in the parade on Saturday, 29.06.2024 at 3 p.m. in the city center.
- (5) For participants with a sales stand or sale of goods, a stand fee will be charged.**

Dues:

- **12,- € per running time meters of floor space**
- **10,- € Connection Luminous flux (220 V)**
- **20,- € high-voltage current (380 V / 16 A)**
- **25,- € Drinking water connection**

An invoice for the stand fee will be issued after the city festival.

- (6) Each participating group must have appropriate liability and accident insurance. Participation is at your own risk. The city of Neresheim as the organizer assumes no liability for the objects or valuables of the participating groups.
- (7) The participant is responsible for obtaining all permits. If permits have to be obtained or granted by the organizer, this must be requested in writing 4 weeks after confirmation. Any applicable taxes and fees (e.g. VAT, social security contributions, etc.) must be borne by the participating group itself and paid accordingly.
- (8) If the city festival is cancelled due to bad weather or for other reasons, you are only entitled to the expense allowance if the cancellation was made at such short notice that the journey to Neresheim has already begun.
